

Board of Directors Nominee Announcement

The date for receiving member applications for nomination consideration to the CBC FCU Board of Directors closed on February 1, 2024. The Nominating Committee has determined that the following candidates are qualified and eligible for installation to the Board of Directors: Kevin Carey; Robert Cabral; and Barbara Winters. Since there is a qualified candidate to fill each Board vacancy for the upcoming term, no nominations from the floor will be permitted during the Annual Meeting.

Kevin Carey, Vice Chairman

Mr. Carey is a retired U.S. Navy Officer with 26 years of service in numerous fleet and staff assignments, including Executive Officer of USS JARRETT (FFG-33) and as Chief Staff Officer and Department Officer at the Naval Surface Warfare Center Port Hueneme Division (NSWC PHD). Mr. Carey has extensive experience with Navy shipboard weapon systems, weapons testing and evaluation and engineering management. After retiring from the Navy he joined SYS Technologies, which was later merged with Kratos Defense and Security Solutions, and held a Senior Management Analyst position supporting the Director, Office of Corporate Business at NSWC PHD until retiring in 2011. He holds a B.S. in Economics degree and a Master of Marine Affairs (M.M.A.) degree from the University of Rhode Island.

Barbara Winters, Board Secretary

Ms. Winters is a marketing executive with over 25 years of experience in sales and marketing roles for technology companies. During her 15 years with Intel Corp she held a variety of positions including global marketing strategy, campaign and brand management, and marketing research. Most recently she was VP of Marketing for a Santa Barbara startup in the big data and marketing technology space.
